Fall/Winter 2018 VENDOR INFORMATION

A \$15 Annual Membership Fee for the Elora Farmers' Market Association is required of ALL vendors. This membership is due at the time of application approval.

FULL TIME: We commit to the full Fall/Winter season from October 27 to December 22, 2018

- If your application is approved, the annual membership fee of \$15* plus the full season amount of \$180.00 for a 10' x 10' stall. This is due on or before the 1st day of fall/winter market, Oct 27, by cash or cheque.
*If you were a 2018 summer vendor you do not have to pay a membership again.
- Fulltime Vendors have guaranteed stall locations.
- There is a \$10 weekly fee for each additional vendor stall 10' x 10' expansion.
- There are no refunds for weeks not in attendance
- Fulltime vendors must be in attendance 80% of the market days for the season.

PART TIME: We commit to periodic attendance at market.

- If your application is approved, the rate is \$25 each week per stall.
- You are required to pay a \$15 membership fee if you were not a summer vendor.
- Stall space is limited to perimeter of market assigned by the Vendor Committee
- No stall location is reserved for part time vendors

Be sure you have indicated if you need electricity and what your usage (amps) will be on the front of the form.
